1 Preamble

By signing the International School of Zug and Luzern's (hereinafter "ISZL") Enrolment/Re-Enrolment and Fees Payment Policy, parents/guardians agree to comply with the provisions of the ISZL's Financial Regulations. It is understood and agreed that the parents/guardians are ultimately liable for all school related fees, including but not limited to, tuition and service fees, regardless of the invoice recipient.

ISZL's Financial Regulations will be updated as necessary and supersede all former financial agreements between parents/guardians and ISZL.

2 Terms and Conditions

2.1 Registration Fee

In the written offer of a place, the school will request a non-refundable registration fee, per student. Upon receipt, a place will be guaranteed at our school. The registration fee is a one-off payment and will not be off-set against the tuition fees or refunded to parents, guardians and/or company.

The registration fee may be waived for a returning student who left ISZL not more than twelve calendar months from the date of re-application and is subject to the approval of the Director of Admissions and Advancement and the Director of Operations.

2.2 Tuition Fees

Tuition fees for the following school year may be subject to cost related increases as approved by the Board of Trustees. Parents/guardians of current students will be informed in writing of any modification to the tuition fees.

2.3 Enrolment

Enrolment is for the whole school year. The tuition fee is payable within thirty days of the date of the invoice or before the start of the next payment period. All other fees are payable as stated on each invoice. All school invoices will be sent electronically. Any bank fees incurred when transferring funds must be paid by the sender. 12% interest per year, will be added to all fees which are past the due date.

Payment options are available in 2, 3, 4 and 8 instalments. These payment options are open to private payers only and must be pre-arranged with the Business Office on a yearly basis (e-mail: billing@iszl.ch). For families who enroll after August 2025 fewer payment options may be available. There is an associated administration fee of CHF 200 per child per year on all instalment options.

Deadline for any new payment agreement is subject to evaluation and approval by ISZL latest by 18th June 2025. Any corrections to the tuition fee invoice (e.g. change of payment terms) requested after this deadline may incur an additional fee of CHF 50:

Any changes to an existing payment agreement after August 2025 will need to be reevaluated and might not be possible.

New students who are enrolled for the new school year or during the school year and who are subsequently withdrawn before the start of their classes, will be charged 25% of the relevant tuition fees unless withdrawal is received at least 4 (four) calendar months prior to the start date.

2.4 Re-Enrolment

Students must be re-enrolled by 31st March 2025 at the latest, in order to guarantee a place for the next school year. If the student is then withdrawn after being re-enrolled, a late withdrawal fee of 25% of the new annual tuition fee will be applied.

Re-Enrolment is subject to approval by ISZL.

2.5 Late Enrolment

Students enrolled between	and	will be invoiced
the start of the first term	September 30 th	100% of the annual tuition fees
October 1 st	October 31 st	90% of the annual tuition fees
November 1 st	November 30 th	80% of the annual tuition fees
December 1 st	December 31 st	70% of the annual tuition fees
January 1 st	January 31 st	65% of the annual tuition fees
February 1 st	February 28 th	60% of the annual tuition fees

Students enrolled on 1st March 2025 or after will be invoiced on a sliding scale until the end of the school year.

2.6 Early Withdrawal

Student withdrawals must be confirmed in writing by both Parents/Guardians unless one Parent/Guardian has sole legal custody. However, this rule does not apply to students withdrawn by ISZL due to unpaid invoices, disciplinary actions, cancellation of enrolment and/or registration.

2.7 Additional Costs

2.7.1 School Bus Service

A separate, additional charge is made for those children using the school bus service. Details on pricing can be found in the School Bus Policy.

2.7.2 Parents Association Fee

A yearly membership fee of CHF 40 per child will be levied on behalf of the Parents' Association. This will be added to the invoice for the school fees.

2.7.3 Other Costs

Certain fees/charges are not included in the tuition fees. These include, but are not limited to: lunch, bus service, College Board/AP/IB registration, BTEC and assessment fees, online courses or additional language courses chosen by families as part of their ISZL education, e.g. Pamoja or VHS courses, optional trips, sports events/tournaments, tutoring, after-school optional lessons, EAGLES Club, damage to school IT devices and/or properties, lost or damaged class or library books.

2.8 Cantonal Support

If there are no changes on Cantonal Legislation and requirements are met, ISZL receives a cantonal subsidy for residents living in the Canton of Zug. Entitlement is for students from Kindergarten to Ninth Grade, who were born before 1st June 2020, have started at ISZL and have been registered with the Canton of Zug by 15th November 2025. As per Cantonal legislation, ISZL deducts half of this subsidy from the annual tuition fee of those students eligible. This process is managed by the Business Office. The other half of the subsidy is used for general educational purposes to the benefit of all ISZL's students.

2.9 Insurance

All children must have their own liability, accident and health insurances upon joining the school.

2.10 Billing

One tuition fees invoice will be issued per child, per payer, per school year, regardless of payment terms.

As part of ISZL's commitment on preserving the environment, all school fees invoices will be sent electronically.

If a company is paying any part of the annual school fees and other fees, a separate form will be issued by the Business Office which must be completed and signed by the company's duly authorized signatory.

A fixed administration fee of CHF 200 may be charged for any special billing requests which includes, but is not limited to, the following:

- Issuance of more than one tuition fees invoice and payment slip, per student, per school year.
- Issuance of more than one invoice and payment slip for a single fee.

A fixed administration fee of CHF 50 will be charged for each request that has been approved by the Primary School Assistant Principal to change a student's Early Years attendance on dates other than those specified on the Early Years Attendance Registration Form.

2.11 Unpaid School Fees/Invoices and Late Payment

In the event of any unpaid invoices which are overdue for more than 60 days, ISZL reserves the right to terminate the enrolment contract. ISZL will coordinate with the local school authorities to prepare for the withdrawal of any student from ISZL and, where appropriate will inform the director of the corresponding local school regarding enrolment of the student by the end of any given semester.

A student's school report, transcript and any other school records may be held back until all outstanding invoices are settled in full.

In the event of an unpaid invoice, third parties may be engaged by ISZL for the recovery of any outstanding fees and costs. For this purpose, ISZL reserves the right to pass on the required personal details to the relevant third-party agency.

ISZL reserves the right to re-allocate the place of a student enrolled for the next school year should the full tuition fee and/or other associated costs due for payment during the current school year not be settled by the end of May of the said school year.

In case of more than one outstanding invoice, any payment will be applied to the oldest invoice.

2.12 Refund of Fees

There will be no refund of fees due to:

- force majeure; and/or
- any decision made by the federal or cantonal government.

Where ISZL is forced to close the school, or part of the school, or can provide only limited services due to reasons beyond its control, there will be no refund of Tuition Fees/Other Fees. This includes, but is not limited to, the following situations:

- war, invasion, rebellion, insurrection or civil war;
- act of Government;
- earthquakes, fire, lightning, storms, floods, severe weather or any other occurrence caused by the operation of the forces of nature;
- strikes, lockouts, sit-ins, work-to-rule, boycotts and/or labour disputes;
- terrorism, sabotage and/or arson;
- infectious disease (Outbreaks, Epidemics, Pandemics);
- significant pollution;
- contamination, radiation and/or ionization of any nature whatsoever;
- any event, occurrence and/or circumstance of whatsoever nature beyond the reasonable control of the school; and/or
- any other event similar to any of the foregoing.

There will be no refund of fees due to student disciplinary actions, suspension, expulsion. ISZL will not grant refunds for any services due or already rendered in the event a student is suspended or expelled from the school due to disciplinary grounds.

2.13 Policies

School policies and regulations are online and available through the school website.

2.14 Amendments

ISZL reserves the right to amend these Financial Regulations as deemed necessary. The Schedule of Fees is updated on a yearly basis, upon approval by the Board of Trustees.

2.15 Disputes and Legal Jurisdiction

The agreement shall be governed by and construed in accordance with Swiss Law. The parties submit to the exclusive jurisdiction of the courts of Zug, Switzerland in relation to any dispute arising from this agreement.
